Privacy Statement

Acceptance of Terms

Your Ability to Edit/Delete Your Information

Because we do not collect personally identifying information (PII), and the information we obtain is automatic through tracking technologies, we cannot provide you the ability to edit or update your non-PII information after it is collected. You can always <u>opt-out</u> though. If you opt-out from tracking technologies, any information that we already have collected or stored may remain in back-up storage for some period of time after your deletion request, but in no event longer than a year. This may be the case even though no more information remains in our active databases.
